- 5) Notarized Certification from other Electric Cooperative and/or Company that the supplier/contractor is not black listed or banned from bidding by the government or any of its agencies and other private corporations or electric cooperatives.
- 6) Compliance with EO #398
  - a. Proof of VAT payment for the past six months
  - b. Tax clearance from the BIR for the last two quarters
- 7) On-going, completed or awarded contract not yet started within the relevant period specifying the following:
  - a. Name of contract
  - b. Date of contract
  - c. Amount of contract and value of outstanding contracts
  - d. Date of Delivery
  - e. End-user's acceptance if completed
- 8) Certification from DOLE
- 9) License to Operate
- 10) Audited Financial Statement
